Extended Warranty for Manufacturers' Parts. Extends the standard warranty two (2) additional years, for a total of five (5) years of warranty coverage.

Extended Warranty for Electronic Components. Extends the standard warranty two (2) additional years, for a total of five (5) years of warranty coverage.

Extended Warranty for Jaco branded LiFePO4 batteries. Extends the standard warranty for onboard LiFePO4 batteries and or POWER BLADE LiFePO4 hot-swappable batteries an additional two (2) years, for a total of five (5) years warranty coverage.

Warranty Clarification and Terms

- All warranty questions start with GCX support. Visit https://www.gcx.com/support/ and submit your support issue.
- **Be near the product in question.** You'll be asked to locate the serial number, and to provide other important information about the product.
- In the case of a return for warranty, GCX will send a replacement at no charge. GCX will ship your replacement part by ground freight, or by other terms specified by any service contract you may have with GCX.
- Onsite support. In most cases, warranty issues can be resolved with part replacement. In the event of a systemic
 cart issue, GCX will dispatch a Factory-Certified Technician to your site to diagnose the failure condition and resolve
 the matter according to the terms of your warranty.

GCX is committed to your satisfaction. We will work with you every step of the way to ensure all warranty repairs and replacements meet your expectations as well as our own rigorous quality standards.

Factory-Direct Integration

We can install and route all power and peripheral cables, with proper strain relief, so that your IT team can connect devices and peripherals easily, and deploy your carts faster.

Onsite Deployment Services

GCX offers a number of services to accelerate cart deployment, and allow your IT personnel to remain focused on their work:

Unloading and unpacking. A Factory-Certified Technician will meet your carts at the loading dock, unpack them, and move them to the location you specify for integration and deployment.

'White Glove' service. A Factory-Certified Technician will meet the delivery truck at your loading dock, unload your carts from the truck, unpack them, move them to the location you specify for integration and deployment, and recycle or dispose of all packaging material.

Onsite integration. To further accelerate deployment, a Factory-Certified Technician will mount and connect all computers, monitors, and qualifying devices and peripherals on your carts, at your site.

Preventative Maintenance

GCX mobile and wall-mounted workstations are maintenance-free by design, requiring only periodic cleaning based on our simple instructions. For customers who prefer it, a Factory-Certified Technician can periodically inspect your workstations at your site and perform minor adjustments that keep them in top working condition for years of trouble- free performance.
